We have replaced the Bronze Pass with a 10 Day Pass, valid for any 10 days during the season without black-out dates.

All business season pass reservations must be submitted with payment **to the Crested Butte/Mt. Crested Butte Chamber of Commerce** by Friday, December 9<sup>th</sup> to receive early season pricing. ## 2011-2012 Business Season Passes

	September 1-December 9, 2011	December 9, 2010-April 8, 2012

10 Day Pass	\$435	\$615

1. A minimum purchase of two passes is required to qualify for business passes.
2. Platinum passes are valid winter of 2011/2012 and summer of 2012. All other passes are valid winter 2011/2012 only. The E-Z Pass is valid one day a week, with the week starting on Sunday.
3. Beginning January 1, 2012 CBMR will refund up to three un-issued passes minus a non-refundable processing fee of \$50.00 per pass. If only one pass is remaining it loses its business pass status. No refunds on un-issued passes after January 31, 2012.
4. Business passes can be reissued (transferred) up to two times to another employee of the purchasing business for a \$50 charge each time, but only after all purchased passes are issued. Business passes may not be transferred to other businesses or to any individual not currently employed by the business who purchased the pass at any time.
5. Businesses, not the individual employees, own the passes. Business passes can be issued only to employees, who work at least 20 hours per week, of the business purchasing the pass. The Crested Butte/Mt. Crested Butte Chamber of Commerce reserves the right to request legal proof of employment from any business at any time. Failure to show legal proof of employment will result in loss of business pass privilege. Passes issued to non-employees will be revoked and the business will no longer be able to purchase business passes for a total of three years.
6. For each pass purchased the employer must complete an authorization form. Passes will not be issued to employees without the proper authorization. Authorization forms will be issued to the employer at the time of purchase.
7. Employees may upgrade their pass to a higher level by paying the difference in price. Upgrades must be done at the time the pass is issued. The upgraded pass remains the property of the purchasing business.
8. The above prices do not include the 4% Mt Crested Butte admissions tax.
