We are very excited about all of the 4th of July activities scheduled this year!

We would like to invite all interested parties to participate in the 4th of July Parade. To make the 4th of July go as smoothly as possible, we are requesting that all parade forms to be returned to the Chamber by July 3rd.

Once again, we will be having a wet zone portion of the parade. Anyone wishing to be a part of the wet zone should line up at the end of the parade on Sopris between Seventh & Ninth St facing Ninth St. The Wet Zone will begin half way between 2nd and 1st Street and will be clearly marked with signs. Parade marshals will be able to tell your float when water use is permitted. Water is not allowed in any area other than in the designated Wet Zone. Please be aware that candy or other items cannot be thrown from floats. You may, however, have people walking next to your float to hand out these items (there must be a person between the crowd and the vehicle). Thank you for your understanding and support of these procedures; they are designed to enhance safety & ensure an enjoyable experience for everyone!
